2. Pasted content may not render well when the bid document is generated. See [Generating a Response Document](#) and [Pasting Response Content from a MS-Word Document](#) . **IT IS THE BIDDER'S RESPONSIBILITY TO ENSURE THAT THE CONTENT THEY ENTER INTO DECISIONDIRECTOR ALLOWS FOR THE GENERATION OF A READABLE BID DOCUMENT.**
